The town with an interesting past (some hundred cultural and historical monuments) and dynamic present.

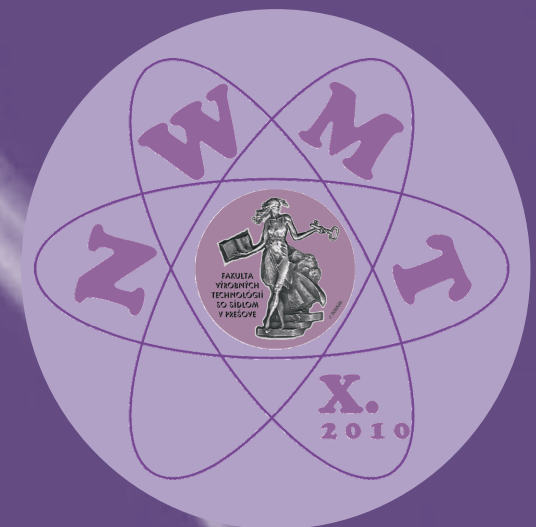
